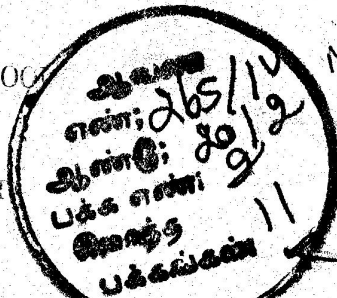
NOW THIS DEED WITNESSETH AS FOLLOWS:-

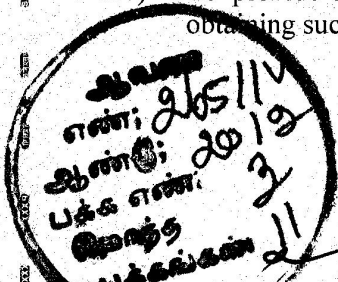

- xv) To establish and run various vocational/skill training centres to help youth to develop their self-employment skills
- xvi) To establish centres for employment generation
- xvii) To bring, publish and sell, distribute books, periodicals, leaflets, brochures and papers and also open and maintain libraries, reading rooms for the promotion of the objects of the Trust.
- xviii) To develop required infrastructure, buildings, and other assets necessary to carry out the objects of this Trust.

**4. Constitution of the Trust Board**

: The Trust Board shall consist of 3 Trustees.

- 1. Founder Trustee
- 2. Managing Trustee
- 3. Financial Trustee

**5. Powers of the Founder Trustee**

Founder of the Trust shall be Executive Head of the Trust. His advice shall be pertaining to the administration of the Trust.

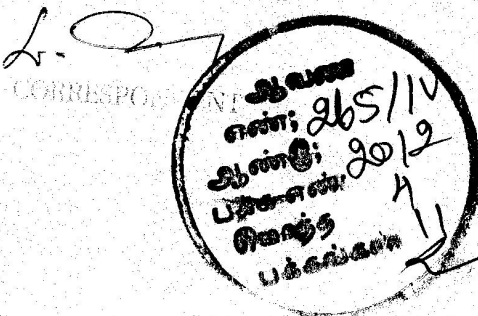
**6. Powers of the Managing Trustee**

- 1. The Managing Trustee shall be the chief-functionary and he would endeavour to meet the object of the Trust in all good conscience.
- 2. He shall lead every meeting of the committee.
- 3. He will give directions in the day-to-day administration of the functioning of the Trust mainly on school activities.
- 4. He is the authorized person to use or to be sued for and on behalf of the trust. He is hereby fully empowered to hire, pay, dismiss and otherwise deal with persons for any and all Trust activities.
- 5. Executive Committee under the leadership of the Managing Trustee may appoint any member or Specially qualified person as a Special Trustee in order to represent the Trust in any particular business of the Trust for a limited period of time.
- 6. The Managing Trustee shall hold the trust fund on the following terms: The Managing Trustee shall be entitled for reimbursement of all expenses incurred by them including Travelling expenses of the purpose of the trust of attending the meeting of the Managing Trustee and are also indemnified in respect of all sets done in the course of carrying the activity of the trust. The Managing Trustee entitled to get remuneration shall pass resolution passed by the Board of Directors.
- 7. To Manage the trust fund and collect and recover the interest, dividends and the other income there of and to pay and discharge out of the income of the trust fund all expenses and charges for collecting and recovering the income of the trust fund and all other costs. Charges and expenses and out going of and incidental to the trust created by these Presents.
- 8. To pay or utilize the income or the trust called the net income of the trust and at the Discretion of the Managing Trustee the corpus of the public charitable purpose set out herein above in such shares and proportions and in such manner in

all respects as the Managing Trustee shall in their absolute discretion think fit. The Managing Trustee herein shall have all the power necessary or incidents for effectually carrying out the objects of the Trust.

9. To apply the trust money to effectuate one objects of or some of the objects of the trust in Preference to the other object(s). To discontinue the application of, trust funds to the objects and divert the funds to another objects of the trust.
10. To receive donations either by cash, a kind or legacy or any other means from foreign Countries or included India by way of corpus of for on revenue account.
11. To expend the funds of the trust in such manner as they consider must beneficial for the objects and purposes of the trust.
12. To acquire urban or agriculture, lands build up on pull down, rebuild, and to at alter repair cultivate or improve sell or dispose of any land, buildings or premises for the use of the trust, and to acquire other is movable intangible benefits of immovable properties to hold the Trust resolution made by the Trustees.
13. To take any property on lease or hire to hold Trust on behalf of the Board of Trustees resolution.
14. To let on hire or lease or other transfer any movable or immovable properties not immediately required by the trustees resolution.
15. To acquire any property in exchange for some other property or partly in such exchange and partly for other considerations with approval by the Board of Trustees.
16. To enter into any contract on behalf of the trust with special resolution passed by the Board of Trustees.
17. To borrow moneys upon the security of any of the properties of the trust with resolution passed by the Board of Trustees.
18. To appoint and remove Managers, Principal, Clerks and other Staff and workers required for the working for general management of the affairs of the trust especially running school administration.

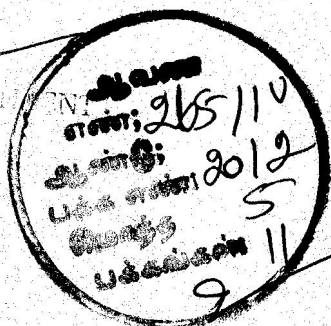
**7. Powers of Financial Trustee:**

Financial Trustee will be in-charge of the accounts, and receipts for the amount in his custody, get the authorization of the Managing Trustee for the disbursements, of money, maintain the accounts, submit the money accounts to the Managing Trustee, and arrange for the audit of the accounts.

The Financial Trustee shall pass resolution by circulation in case of an urgent issue. They may make rules for regulating their meeting and the trustees may repeal later any rules made pursuant to this clause.

To Manage the Trust Fund and Collect and recover the interest, dividends and other income there of and to pay and discharge out of the income of the trust fund all expenses and charges for collecting and recovering the income of the trust fund and all other costs. Charges and expenses and out going of and incidental to the trust created by theirs presents and the administration thereof.

To pay or utilize the income of the Trust called the net income of the trust and at the discretion of the trustees the corpus of the public charitable purpose set out here in above in such shares and properties and in such manner in all respects as the trustees shall in their absolute discretion think fit. The Trustees herein shall have all the power necessary or incidental for effectual carrying out the objects of the trust.

#### **8. Meeting of the Board**

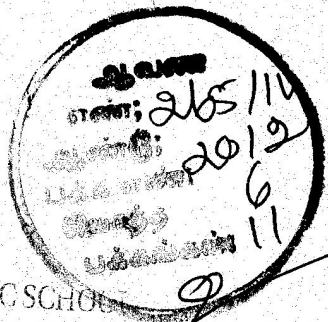
- (i) The Board shall hold an annual meeting for the purpose of the approving the audited statement of accounts and the report of the Founder and Trustees of Board.
- (ii) The Board shall transact any business that may be specified in the Agenda or otherwise agreed to by the Board of Trustees.
- (iii) The Board shall also appoint an Auditor at the annual meeting for the subsequent year.
- (iv) Three Trustees of the Board shall constitute the quorum;
- (v) The meeting of the Board shall be convened after giving at lease a week's notice unless those who are entitled to receive notice agree to accept the shorter notice;

#### **9. Accounts and Audit:**

- a). Proper and regular books of account of all receipts and expenditure of the Trust shall be maintained by the members either in English or in Tamil.
- b). On the 31<sup>st</sup> March of every year a general account shall be taken for all the assets and liabilities of the Trust and an Income and Expenditure Account for the whole year and the Balance sheet as on 31<sup>st</sup> March shall be prepared and shall be passed by the Board of Members. The accounts of the Trust shall be audited annually by a Chartered Accountant Appointed by the Board of Trustees for the purpose.

#### **10. Bank Account:**

The Trust shall open the Bank Account in the name of the Trust by Managing Trustee and Financial Trustee Jointly any type of account in any bank operated either the Managing Trustee or Financial Trustee between any one individually. And to execute the necessary document for receiving loans through banks and the documents so executed by the Managing Trustee with resolution made by Board of Trustees.

**11. Visiting:**

The Board of Trustees approval Managing Trustee have here in may maintain & list of properties acquired, administered and maintained by the Trust school administration and the same.

**12. Amendments & Alterations**

While this deed of trust shall be irrevocable the board may amend the caused relating to the membership and the management at a duly convened meeting of the Board. However, all such amendments shall be effected subject to the prior approval of Commissioner of Income Tax.

**13. Extinction of Trust**

Subject to section 77, 78 and 79 when its purpose is completely fulfilled or when its purpose become unlawful or when the fulfillment to the purpose become impossible by destruction of the trust property or otherwise or when the trust become revocable is expressly a revokes the properties and funds belonging to the trust shall be applied for such allied purpose as the board may determine including handling over the properties and funds to similar charitable trust already recognized by the Commissioner of Income Tax under the Income Tax Act.

**14. Legal**

The Managing Trustee have here in may maintain & list of properties acquired, administered and maintained by the Trust and the same all always best with the trust Board.

**15. Advisory Board**

The Managing Trustee herein may maintain a list of advisers for better administration of any particular objects by engaging there services. The Trustees shall have liberty to fix remuneration for the services rendered by the advisers.

**16. General Function:**

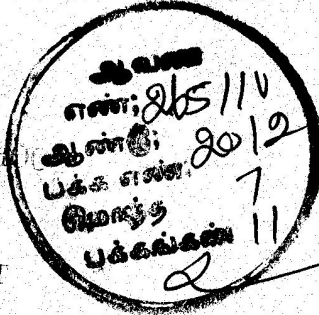
1. This Trust is irrevocable. If the Trust hereby constitute fail for any reason in the opinion of the Managing Trustees of the Trust the net assets of the Trust both movable and immovable shall be Handed over to any public charitable trust as decided by the majority of the Trust Board.

2. In the event of closure of winding up dissolution of the trust all its assets and liabilities, if any shall be transferred to another trust which has similar objects of any enjoying exemptions us.11 and 80G of the Income tax Act 1961.

3. The Trust shall invest its income available for investment from time to time in specific mode of investments as per section 13 (i) (d) read with sec. (ii) (5) of the Income Tax Act. 1961.

4. The Income and funds of the Trust shall be solely utilized towards the objects of the trust and no portion of its income shall be utilized for payment to trustees by way of remunerable on profit. Interest dividends, etc., in section 13 (1) c & the Income tax Act 1961.

5. The funds of the Trust would not be applied for any religious purposes or given to religious in institutions.

6. Any amendment to the instrument would be carried only with the approval of Income Tax Authorities (Exemptions).

7. Acquisition/Alienation of immovable property shall be done with prior approval of Income Tax Authorities (Exemptions).

8. The benefits of the Trust are open to all in the Society at large irrespective of caste, creed, religion, sex etc.,

9. The activities and functions of the Trust shall be utilized only towards educational & charitable purpose and not for any profit motive.

10. At present the trust have no immovable property. No activities of the trust will be carried out any where out side India, without prior permission from the appropriate/concerted authority of Department of Income Tax.

#### **17. Investment of the Trust**

In the event of dissolution of winding up of the Trust, the assets remaining as on the date of dissolution shall under no circumstances be distributed among the trustees, but the same shall be transformed to another charitable Trust, society, Association or institution whose object are similar to those under 80 G of the Income Tax Act 1961.

#### **18. Indemnity**

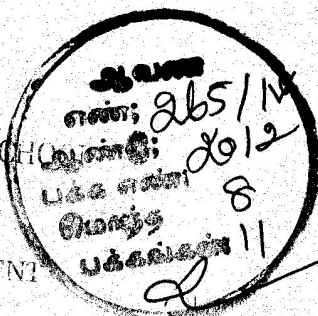
The Trustees shall be kept indemnified and harmless by the Trust against any action claim, demand or liability arising against them for anything done by them in good faith, pursuant to the power of authority vested in them under these presents.

#### **19. Properties Vested in the Trust**

- a) The Managing trustee shall and will possessed of the said sum of Rs.5,000/- upon trust and also of and other capital money and or properties which the founder trustees may form time to time acquire or receive by way of gift / donation or grants for augmenting the trust and with donations or receipts may be accepted for the general purpose of the Trust or for any special or specific purpose connected with the objects of the Trusts indicated by the donor.
- b) The said sum and all money, securities, properties movable and immovable which trustees hereinafter receive or acquire towards the trust fund and all additions and accretions there to and income there from shall constitute the trust properties which shall stand vested in the trust objects to the provision hereof. All assets of the Trust shall be held by the Trustees in the name of the Trust.

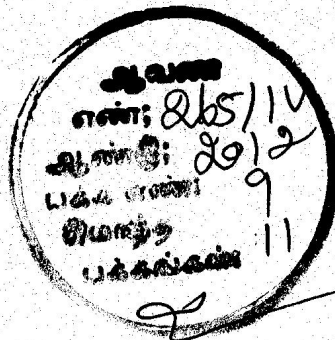
